Deposit \$75.00 – required prior to release of video tapes from the F.C.G. offices. Deposit must be pre-paid using cash, check, credit card, Or invoiced to active clients in good standing.

Weekly Rental Fee: \$15.00 per week minimum plus shipping fees, if applicable.

Extended Rental Period: \$5.00 per day for an additional 14 days, with written notification and approval from F.C.G. only.
\$10.00 per day for additional 14 days if written notification or approval has not been obtained.

Maximum Rental: 3 weeks (21 days) maximum – DVD kept beyond the maximum time limit shall be charged a fee of \$300.00 whether the DVD is Returned to F.C.G. or not returned.

In consideration of the above terms, the remaining balance of the deposit shall be credited to your account based on the return date of the DVD.

DVD's found damaged upon return, your company shall be responsible for a replacement fee of \$395.00.

All charges, as described above, shall be charged to your credit card or invoiced to your account.
